#### New European Panasonic Industry Company – Merger of PIEU and PEWEU

Dear Valued Customer,

We are pleased to announce that **Panasonic Electric Works Europe AG** ("PEWEU") has been merged into **Panasonic Industry Europe GmbH** ("PIEU") with effect as of September 25<sup>th</sup>, 2022.

Following the merger PIEU continues the business under its current name and have its headquarters located in Caroline-Herschel-Strasse 100, 85521 Ottobrunn, Germany.

This strategic corporate re-organisation will strengthen our position in the market and create an even stronger business partner for our customers. Our customers will benefit from the combined experience and high-quality capabilities as well as from the unified portfolios of products and services.

Upon registration of the merger into the commercial register on September 25<sup>th</sup>, 2022, all commercial agreements and similar legal relationships of PEWEU have been fully and automatically transferred to PIEU in accordance with the applicable provisions of the German Reorganisation of Companies Act (Umwandlungsgesetz). Therefore, neither an amendment nor a novation of existing agreements is necessary.

Furthermore, we would like to enter into a direct dialogue with you regarding the transmission of business information via Electronic Data Interchange (EDI). Due to an organizationally necessary transitional period we would like to inform you that the existing separate EDI connections as they are currently in place for PIEU on the one hand and for PEWEU on the other hand will need to be retained technically unchanged from the merger date until March 31<sup>st</sup>, 2023. Transactions concerning the former PEWEU business during that period will need to continue to be processed through the respective EDI channel.

Additionally, we herewith would like to inform you that for payments the actually used bank accounts will remain unchanged during the period between merger date to March 31<sup>st</sup>, 2023.

Accordingly you will receive from October 2022 onwards invoices exclusively under the new company of PIEU. However, we kindly ask you to keep the existing bank accounts up to 31<sup>st</sup> of March 2023. To identify the invoices based on the current creditors we will keep the information of the old company name as an amendment as follows:
